Position: President

Shall submit a resume with a documented history of successful leadership and supervisory experience and possess skills related to organizational management with a fine attention to detail and 2 recommendations which are reviewed with the board.
- **Position Description:** The President is a voting member of the Board of Directors and is responsible for ensuring that the activities and objectives of the association are conducted and communicated to all constituents, which exemplify the highest standards of OT practice in the state. The President shall be the chief elected officer of the Corporation and shall preside at all meetings of the Corporation and shall fulfill other duties incident to the office of the President.

Position: Vice-President

- Qualifications: Shall be an occupational therapy practitioner licensed in the State of Connecticut and in good standing with ConnOTA. Shall submit a resume with documented successful leadership and supervisory experience.
- Position Description: The position of vice president is a voting member of the Board of
 Directors position of administrative affairs of the organization, including orienting new
 board members, monitoring and maintaining the annual calendar and ensuring the timely
 completion of action items for the board. The Vice President shall fulfill all presidential
 duties in the absence of the President and shall fulfill other duties incident to the office of
 the Vice President.

Position: Treasurer

- **Qualifications:** Shall be an occupational therapy practitioner licensed in the State of Connecticut and in good standing with ConnOTA.
- **Position Description:** The position of Treasurer shall be a voting member of the Board of Directors to ensure the complete and accurate financial accounting of the association. The Treasurer shall oversee the financial affairs of the Corporation and shall fulfill other duties incident to the office of the Treasurer. Shall be bonded at the expense of the Corporation.

Position: Membership Chair

- **Qualifications:** Shall be an occupational therapy practitioner licensed in the State of Connecticut and in good standing with ConnOTA.
- **Position Description:** The position of Membership Chair is a voting member of the Board of Directors who seeks to increase membership and involvement of the membership in the activities of the association. This position consists of 2 Chair positions.
